



Instructions to the bidder

- 1) The bid should remain valid for a period of 60 days. In case your offer has a different validity period that should be clearly mentioned in the quotation. Validity period may also be extended without change in bid prices, if required on mutually agreed basis only.
- 2) Entry Tax: The State of Chhattisgarh charges entry tax on all goods entering the State. Please include it in your quotation as a separate item. Entry Tax will be reimbursed on production of proof of payment.
- 3) Please address your quotation with all the required documents to :
“Principal, Government Lal Chakradhar Shah College, Ambagarh Chowki (C.G.)”
and super scribe the envelope “**Quotation for laboratory Equipments**, Government Lal Chakradhar Shah College, Ambagarh Chowki (C.G.)”.
- 4) Technical brochure/catalogue should also be enclosed to support the specification of the items (Technical bid- envelope no-1).
- 5) **Warranty/maintenance Period:** The warranty period should be minimum 2 year (with spares) until and unless specified differently from the date of installation. For standard items which carry warranty of more than one year, standard warranty shall be applicable.
- 6) Total five years of maintenance shall be provided by the suppliers.
- 7) **Terms of Payment:** The method and conditions of payment to be made to the Supplier under this Contract shall be as follows:
Payment for Goods and Services offered from India/abroad in INR: Payment shall normally be made in Indian Rupees, as follows: 100% payment will be made in account payee cheque or Draft to the Supplier within thirty (30) days after the successful installation and commissioning of equipments subject to submission of performance security.
- 8) Earnest money should be in favour of “ Principal, Government Lal Chakradhar Shah College, Ambagarh Chowki (C.G.)”

Note:

1. The nomenclature used for the item description in the invoices(s), packing list(s) and the delivery note(s) etc. should be identical to that used in the contract. The dispatch particulars including the name of the transporter should also be mentioned in the Invoice(s).
2. The above documents should be received by the Purchaser before arrival of the Goods and, if not received, the Supplier will be responsible for any consequent expenses.
3. **Delivery period:** Delivery should be made within 15 days from the date of order of placement of goods offered. However early delivery shall be appreciated.
4. Any disputes arising out of this enquiry shall be dealt in the Rajnandgaon jurisdiction.
5. Bidder need to submit the following certificates along with the quotation for technical bid in Envelope-1 clearly mentioned with ‘ TECHNICAL BID’. The enclosure for the technical bid must as follows:
 - i. Technical Specifications details of the Equipment
 - ii. Proof of establishment of Firms/shop/business/ manufacturing unit etc. and dealership certificate from the Principals etc.
 - iii. Proof of **GST** registration as per applicability.
 - iv. Photocopies of the latest purchase orders received from IITs/NITs/any central govt. organization/State Govt. Organization/reputed private sector organization for the offered item.
 - v. Authorization certificate
 - vi. Propriety Certificate stating that they are the only source of supply/Manufacturer.
 - vii. Proof of PAN
 - viii. User list IITs/NITs/Central govt. organization/ State Govt /reputed private sector Organization for the offered item.



- ix. Warranty certificate for at least 2 years separately for each instruments.
 - x. Five years of maintenance affidavit after 2 years of warranty.
 - xi. Any other relevant document, if any
